## StockSnips Al-Powered Sentiment US All Cap ETF



**Fund Objective** 

Seeks long-term capital appreciation.

### **Process & Methodology**

NEWZ is an actively-managed ETF and leverages a proprietary Investor Sentiment signal, which uses advanced artificial intelligence ("Al") and natural language processing to invest in securities of U.S.-listed large, mid and small capitalization companies with the most positive news coverage. These investor sentiment signals are derived using algorithms that transform unstructured textual data from news articles into quantified real-time sentiment signals. Such news is collected from reliable online sources including news articles, blog posts, SEC filings, and earnings transcripts. StockSnips gathers news information on a daily basis.

#### The **NEWZ ETF** strategy comprises of four steps:

- The security selection process begins with an investment universe of all U.S. listed equities.
- 2. Excluded are certain industries that are cyclical like energy, banks, and building products. Also excluded are any securities that have (i) less than \$2B market cap, (ii) high volatility as compared to the market as measured by a beta of equal to or greater than 1.5, (iii) a return on equity less than 15%, and (iv) less than a defined volume of news coverage. This typically yields a universe of approximately 350 securities.
- 3. The fund then utilizes its algorithms to select the top 30 50 equity sentiment leaders amongst the remaining universe.
- The portfolio is equally weighted, and rebalanced and reconstituted on a monthly basis.
